### TERMS

#### Orders:

First time orders must be accompanied by a certificate of sales tax exemption. A minimum of \$125 is required on opening orders. Subsequent orders must be \$100 and may be submitted by phone or fax. Prices are subject to change without notice.

\*Style Minimums are 5 per product design.

#### Payment:

Opening order is to be pre-paid by check and will be held until payment clears. Net 30 terms are available upon credit approval for subsequent orders. For net 30 terms, payment must be received within 30 days of invoice date. There will be a \$30.00 charge for all returned checks and orders will not be processed on past-due accounts. A late fee of 2% will be charged until account is made current. Past due accounts are subject to all attorney and collection fees.

#### Shipping & Handling:

We ship via ground delivery to the shipping address stated on the order form. Shipping and handling charges will be applied to each order and delivery address on your final invoice.

#### Delivery:

We ship via ground delivery. We strive to ship within 2-3 weeks of order, however; due to the handmade nature of our products it may take longer. If we anticipate a delay in shipment, we will estimate a new delivery date. Show orders will ship on date requested eight - ten weeks after order date or as ready.

All sales are final; however we will gladly replace any damaged product. We ask that you call us within two weeks of receipt for return instructions. Upon our receipt of the damaged product, we will promptly ship out a replacement.

All of our products are made, printed and packaged in the U.S.A. Our Whimsy Cards and Whimsy Kits are all hand-cut and assembled. Due to the handmade nature of our product line, cardstock and colors will vary.
